He holds a Ph.D. in Veterinary Medicine and a Diploma in Development and Environment and has over twenty years of experience in the preparation and implementation of both development and emergency programs in Africa and Asia.

Danièle Bélanger is trained in sociology and demography. She is currently Professor in the Department of geography, at Université Laval in Québec City, Canada. She holds the Canada Research Chair in Global Migration Processes. Her recent research focuses on global migration policies and on migrants in precarious situations.
